

HARYANA KISAN KALYAN PRADHIKARAN, PANCHKULA

In exercise of the powers conferred by section 36 of the Haryana Kisan Kalyan Pradhikaran Act, 2018 (21 of 2018) and all other powers enabling it in that behalf, the Pradhikaran hereby makes the following regulations, namely:

1. (i) These regulations may be called the Haryana Kisan Kalyan Pradhikaran Regulations, 2022.
(ii) They shall come into force with immediate effect.
2. (i) In these regulations, unless the context otherwise requires;-
 - (a) "Act" means the Haryana Kisan Kalyan Pradhikaran Act, 2018 (21 of 2018);
 - (b) "Pradhikaran" means the Haryana Kisan Kalyan Pradhikaran established under sub-section (1) of section 3;
 - (c) "Member" means the member as mentioned in section 4 and section 10(2);
 - (d) "Chief Executive Officer" means the Chief Executive Officer of the Pradhikaran;
 - (e) "Council" means the Agriculture Advisory Council constituted under section 10(1);
 - (f) "Government" means the Government of the State of Haryana.(ii) Words and Expressions used herein and not defined above shall have the meanings assigned to them in the Act or the Rules.
3. The Head Office of the Pradhikaran shall be at Panchkula or at any other place as may be decided by the Pradhikaran.
4. The Pradhikaran shall follow the office timings and holidays as notified from time to time by the Government for its offices, unless otherwise decided by the Pradhikaran in the interest of timely disposal of its business.
5. The Pradhikaran shall have its own seal. Any document requiring authentication by the Pradhikaran shall be issued under the seal of Pradhikaran. The seal shall remain in the custody of Chief Executive Officer or any other officer authorized by him in this behalf.
6. In the matter of appointment of temporary staff, the policy issued by the Chief Secretary to Govt. of Haryana from time to time, shall be followed.

7. The declarations by the officers and Members of the Pradhikaran and the Council shall be made in Form-A.
8. The coordination committees and standing committees shall have a Member of the Pradhikaran as Chairperson and not more than five other members. The Chairperson and Members (Non-official only) will be paid Rs. 3000/- for attending a meeting of the Committee and travelling expenses as payable to Group A Officers of the Govt. The boarding & lodging arrangements will be made by the Pradhikaran on need basis.
9. The experts shall be engaged for undertaking specific jobs, projects, studies, research works etc. The expert shall be an eminent person having knowledge of relevant field such as serving or retired Professors, Associate Professors, Scientists, Govt. Officers, Progressive Farmers, Agri- Entrepreneurs etc. The fee/ remuneration to the expert shall be paid as under:-
 - (a) Chairperson of Working Group – Rs. 50000/-.
 - (b) Member of Working Group – Rs. 25000/-.

The Chairperson and Members will be paid Rs. 3000/- for attending a meeting of the Working Group and travelling expenses as payable to Group A Officers of the Govt. The boarding & lodging arrangements will be made by the Pradhikaran on need basis.

The fee/ remuneration shall be paid on submission of the report by the Working Group.

For other purposes the experts may be hired by the Chief Executive Officer at such remuneration as considered appropriate on case to case basis depending upon the nature and quantum of the task assigned.

The period of the engagement shall be commensurate with the amount of work involved in the assignment and decided on case to case basis.

10. The funds may be invested in government securities, bank deposits or such other instruments as decided by the Pradhikaran from time to time.
