Terms of Reference:-

1. To review the current status of cultivation of Medicinal and Aromatic Plants in Haryana and suggest measures for improvement.
2. To analyze the current support system (schemes, policies, technical and infrastructural support) for promotion of cultivation of Medicinal and Aromatic Plants in Haryana from the State /Central Governments and propose measures/ methods for further improvement in this area.
3. To assess the present status of training programs and extension facilities for farmers and suggest measures for skill development of persons engaged in cultivation of Medicinal and Aromatic Plants in Haryana.
4. To review the status of research and development and suggest measures to address current gaps as per the specific needs of the farmers.
5. To recommend most appropriate strategies for promotion of cultivation of Medicinal and Aromatic Plants in the State.
6. The Working Group may hold consultation meetings with farmers, scientists, entrepreneurs, policy makers, etc.

7. On submission of the report, Members will be entitled for a lump sum honorarium of Rs. 25000/- each, whereas the Chairperson will be paid an honorarium of Rs. 50000/-.
8. Members will be paid TA for attending meetings on the rates as allowed to the Group "A" Officers of the State Government and an amount of Rs. 3000/- for each meeting.
9. The Pradhikaran will bear the cost of typing, printing etc. and for conducting the meetings/consultations.
10. The Working Group should submit its report within a period of four months.
